Each year on the first Wednesday of April, which is Sexual Assault Awareness Month, we celebrate Start by Believing Day. This annual event provides an opportunity for communities across the country, and around the world, to unify with a single voice for those who have been victims of sexual violence: **We hear you.** On this day, we gather to end the silence and change the way we respond to sexual violence: **We see you**. Help us celebrate Start by Believing Day by participating in our **Turn Summit County Teal** challenge!

Every 73 seconds, an American is sexually assaulted. Unfortunately, as few as 1 in 5 victims report their sexual assault. While there are many reasons victims of sexual assault may not want to come forward, the most prominent reason is fear of not being believed. We can change this, but we need your help. Please join us in taking the Start by Believing pledge and helping us **Turn Summit County Teal**.

Start by Believing is a public awareness and action campaign created by End Violence Against Women International (EVAWI) in 2011 to end the cycle of silence and change the way society responds to sexual assault. In April 2019 the Summit County Prosecutor's Office joined this movement by launching our campaign to improve Summit County's response to survivors of sexual violence. The movement focuses specifically on support for survivors, rather than doubt, shame, or blame.

Turn Summit County Teal Challenge
