Winners of 2020 Safety Kids Calendar Announced

Annual Event Sponsored By Summit County Prosecutor's Office

AKRON, Ohio (Thursday, November 07, 2019) – Summit County Prosecutor Sherri Bevan Walsh announced today the winners of the 2020 Safety Kids Calendar contest. Of the over 1,200 posters submitted from 15 different schools, Holy Family's Annika Miller's entry was chosen as the grand prize winner. Annika's poster, which told kids "there's no escape if you vape", focused on a new and very dangerous trend for teens. Her creativity also told a strong message about being safe.

This year, for the first time in the 18 year event, one of the safety rules changed. Students put together posters telling people that it's NOT SAFE TO VAPE. According to the Centers for Disease Control and Prevention, 37 people in the U.S. have died as a result of using e-cigarettes. As of last month, the CDC says there have been nearly 1,900 cases of lung injuries across the country related to the use of e-cigarettes.

Prosecutor Walsh, along with emcee Tim Daugherty from WONE-FM, presented the 54 winners with congratulatory certificates and Amazon gift cards on Wednesday, November 6, 2019, in front of a packed audience of family, friends, teachers and poster judges. The evening started with an A cappella rendition of the national anthem sung by the Miller South School Choir.

"The creativity and skill of the students who enter this contest is outstanding. This is not an easy contest to win as each year the posters get better and better. I am so impressed by the students' creativity, enthusiasm, and talent. I am proud to celebrate their incredible artwork," said Prosecutor Walsh. "Also, I felt strongly about including a warning about vaping. As Summit County Prosecutor, I work hard to make the community safe. That includes addressing this significant health issue. Families need to know that it is not safe to vape."

In addition to the 12 Ways to Stay Safe, the contest includes two additional categories called "Prosecutor Picks". This is the second year six additional posters were chosen for either their humor or creative message.

A big thank you as well to the Miller South School Choir for their beautiful singing, the Akron-Summit County Public Library for hosting the event, Lamar Advertising for providing billboards, Tim Daugherty for emceeing the ceremony, and Source3Media for creating the calendars and taking pictures at the ceremony.

Each of the first-place posters will be featured in the 2020 Safety Kids Calendar and on billboards throughout Summit County. The grand prize and first-place winners and their posters will also be included in a PSA with Prosecutor Walsh that will air on WBNX-TV: The CW during the holidays.
