(Akron, July 26, 2011) ... "Michael Wilmoth has not always been the father that he wanted to be," said Prosecutor Sherri Bevan Walsh when announcing the winners of the Child Support Enforcement Agency's (CSEA) "Dad and Me" photo contest, "but look at him today!"

Walsh continued, "Micael has had challenges paying his child support. He was convicted of criminal non-support in 2007 and 2010. You wouldn't know that today, however, as he is consistently paying child support and filed for visitation rights to see his son. This is a "good job, dad," moment and we want to recognize him, his son, and mom for their hard work."

Wilmoth said when receiving the tickets, "I can 100 percent say if you will work with the Child Support Enforcement Agency, they will work with you. I had the mind set that I had to avoid those people; I have learned that they are not only nice to work with, they will help you work out your child support and help you get on the right track. It is better for yourself, because you are not going to court; it has been better for my son, because he is not only financially supported but I am communicating better with his mom, which has improved our relationship. All the way around, it is better." Wilmoth is currently a student at the University of Akron and has a photography business.

Walsh concluded, "We know that without the emotional and financial support of a father, children are more likely to experience poverty, illness, drug and alcohol abuse, incarceration, teen pregnancy, and emotional educational neglect. The support of a father is priceless."

Wilmoth was awarded tickets for four to Geauga Lake's Wildwater Kingdom. Second place was awarded to Christine Murphy, who submitted a photo of her son Mike Malcosky, and grandson Michael Malcosky, Jr., spending quality time sled riding.
