### BEWARE OF HOME REPAIR SCAMMERS

In December, an 82-year-old man hired a company to cut down a tree on his property. While cutting the tree, a large portion of the tree fell onto the man's back porch and crushed him beneath it. The elderly home owner suffered multiple injuries including broken hips, spinal fracture, broken shoulder, and a broken leg.

It was later discovered that the defendant's business was not licensed in the county to conduct door-to-door solicitation and he had forged documents to make the business look legitimate. The defendant also possessed business cards and documents of other businesses that were not legitimate or licensed. The Company's owner was eventually criminally charged.

**Be wary of any businesses going door to door offering services for extremely low prices.** Also, do not hire any businesses that are unable or refuse to provide proof of licensure and registration.

I would offer these tips when hiring anyone for home repairs:

- Get at least three estimates before hiring someone.
- Check the business with the Better Business Bureau ([www.akronbbb.org](http://www.akronbbb.org)) or call them at (330) 253-4565 to see if the company has a good rating. You can also call the Summit County Office of Consumer Affairs at (330) 643-2879 for guidance.
- Take pictures of the area needing repair before work starts, during and after work is completed to document the repair process.
- If someone starts repairs on your home without your permission, call the police immediately.

Many business scams are able to entice victims by offering services or products for a very low cost. While these offers might seem like a good opportunity at the time, they often can end up costing you way more in the long run such as the case involving the fake tree removal business.

It is important to report any suspicious businesses to the local authorities so others will not fall victim to their crimes.

## ARE YOU KEEPING SECRETS?



Two Akron men have recently been found guilty in very shockingly similar cases. In November of 2016, 24-year-old Akron resident, Nathan Huff, called

911 to report that he had found his 70-year-old grandmother stabbed to death in her home. Later in an interview with police, Huff confessed to stabbing and killing his grandmother himself. The suspect was a known user of methamphetamines and had been using the drugs the night of the killing. He was eventually sentenced to life in prison.

More recently, another Akron man, 49 years old, was charged with stabbing and killing his 78-year-old mother. The suspect was a recluse and was diagnosed with major depression and anxiety disorders. He was the sole caregiver for his mother, who suffered from Alzheimer's at the time of the murder.

These two cases are shocking reminders that even the ones closest to you might be capable of committing horrendous crimes or acts of violence towards you. It is always good to watch the behavior of those around you and look for warning signs that might result in violence, such as signs of drug use, temperament issues, antisocial behaviors, etc. If you notice any suspicious or odd behavior from those around you, do not hesitate to contact your local police. You can also reach out to other relatives or friends for help. Keeping secrets could put your life in danger!

## HERE IS WHAT SHERIFF STEVE BARRY DOES FOR SENIOR CITIZENS

Community policing has become a big part of the Summit County Sheriff's Office.
