# **SUMMER VACATION SAFETY**

Summer is finally here! It's a time when many of you hit the road for vacation. I want to make sure you're safe and you return to a secure home.

You have your tickets and your hotel reservation, but how much preparation have you put into making sure your home is secure while you're away?


Criminals look for the easiest targets and the path of least resistance. It can only take a few seconds for someone to break into your home. But you can stop a criminal in their tracks.

Curb appeal is great when you're trying to sell your home. However, you want to make your home the least appealing one on the block for criminals. Keep bushes and shrubs trimmed to ensure the doors, windows, and garage are visible from the street. Also make sure the areas are well-lit at night.

Having a home alarm system is a great deterrent, but even if you don't have one, you can display an alarm company sign.

We all forget our keys and lock ourselves out of our home. It's a great idea to leave a spare key well

hidden. Criminals know what those hide-a-kev boxes look like and all the typical hiding spots, such as under a rock, planter or mat by the door, or on top of the door ledge. Instead, get a coded key box or leave a spare key with trusted neighbor.



What can you do if someone does break into your home? It takes a thief just seconds to break in to your home and then another three to five minutes inside looking for valuables.

A burglar's first step is the master bedroom and master bath, so find another location to store valuables.

The most valuable thing a thief can take is your identity, so don't leave documents with sensitive personal information out in the open or in easily accessible places. And finally—DON'T FORGET TO LOCK YOUR DOORS AND WINDOWS!



Now that your home is secure, what do you do once you head to your vacation destination?

- Never put your home address on your luggage tags. Write your phone number instead. That way if your luggage gets lost or stolen, strangers don't know where you live.
- Make copies of all important documents, like your credit cards and passport. Take one copy with you (pack it separately from the cards themselves) and leave one copy at home.
- Stay off social media. Don't tip off criminals by sharing too much information on Facebook, Twitter, and Instagram (kids too!) Try not to post photos, status updates, or "check in" while on vacation.

Following these simple tips can help you and your loved ones focus on having fun instead of worrying about safety

The Longest Day coincides with the first day of summer the longest day of the year - to fight the darkness of

Alzheimer's. We wear purple to show support for people caring for those who are battling this condition.



The Summit

County Prosecutor's Office also provides assistance for families with people who battle Alzheimer's, dementia, and other conditions which increase the chances they might wander and make it difficult for them to communicate.

Take Me Home is a secure database, accessible only by law enforcement, which is used to help reconnect caregivers



with children and adults who have a difficult time communicating and may wander from home. This includes people who may suffer from Alzheimer's disease.

The database contains a photo, contact information, and identifying characteristics that can be searched if a person is reported missing or is found wandering.

# AKRON POLICE SGT. TONY STARVAGGI & DET. RICHARD DONEY

### **NOMINATED BY ASSISTANT PROSECUTOR ZACHARY NEUMANN**

Our job as prosecutors is to hold people accountable and keep the community safe. We can't do that without the great work of local law enforcement.

Recently, a violent criminal who terrorized one Akron neighborhood was sentenced to over 40 years in prison. The work of two Akron Police Officers was instrumental in getting that positive outcome.

I nominate Sergeant Tony Starvaggi and Detective Richard Doney for their work on the Kevin Carter case.

Last year, Carter robbed a man at gunpoint, forced him to strip naked, tied him up with a dog leash, and then forced him into the trunk of a car. The victim was eventually able to escape. In a separate incident just one week later, Carter shot at two men, hitting one of them. Det. Doney was assigned to the first case and Sgt. Starvaggi began investigating the second incident.

The first step was identifying the suspect. Det. Doney built up enough trust with the victim, to the point where

the victim finally felt comfortable enough to identify Kevin Carter. The victim was terrified and feared retribution. Sgt. Starvaggi ordered records on a cell phone discovered near the shooting. During his investigation, Sgt. Starvaggi discovered one of the victims had been arguing with Kevin Carter at the time of the shooting.

The cell phone records showed Carter was the owner of the phone. Also on the phone was a picture of Carter holding two guns taken the day before the shooting.

After several months of investigating, the two officers turned two extremely violent acts by unknown assailants into two cases resulting in a jury trial conviction for all charges and a 41 and half year prison sentence for Kevin Carter.

### JOSHUA MIKTARIAN—EOW JULY 13, 2008

For most, this time of year is filled with summertime fun and laughter. But for our office, it is a time of sadness. It's when we lost one of our heroes.

July 13 marks 11 years since tragedy struck our community. July 13, 2008, Twinsburg Police Officer Joshua

Miktarian was shot and killed during a traffic stop.

Miktarian was just 33-years-old when he was killed in the line of duty, leaving behind a wife and young daughter.

Officer Miktarian's death was the first in Summit County in 17 years. His death has impacted us to this very day.



Officer Miktarian was an outstanding representative of the Twinsburg community. He spent his career dedicated to helping people throughout Summit County.

Officer Miktarian went by many names — "Captain Justice" or "Mr. Invincible" to many, "The Pizza

Man" to others — and is missed by all of us.

Police officers put their lives on the line every day to protect our community. We give a heart-felt thanks for their work and sacrifice.

Thank you Officer Miktarian and our law enforcement community for keeping us safe.
