# **AVOIDING ONLINE SCAMS**

The holidays will soon be here. It can be a frantic time as we get ready to have friends and family over to celebrate. Oh and don't forget about holiday shopping!! The crowds alone can make your head spin.

This time of year is also a perfect time for criminals. They know you're busy running around and distracted. So they jump in like a lion attacking its prey. However, there are ways to protect yourself and keep you and your family safe.

We're all looking for the best deal. Maybe you found the perfect item on one of those buy/sell/trade websites and apps like Craig's List, Let Go, and Offer Up. So you set up a time to meet with the seller. This is also a perfect opportunity for a criminal to pounce.

My office has prosecuted numerous cases where the victim was supposed to meet another person to buy something but was instead robbed.

Some local police departments have created "safety zones" as a safe meeting place for making a transaction. The following "safety zones" have video surveillance and monitoring to make sure your sale or purchase happens without incident.

- Summit County Jail 205 E.
   Crosier Street, Akron visitors' parking lot from 8am-8pm.
   Parking spots have 24 hour surveillance.
- Cuyahoga Falls Municipal Building — 2310 2<sup>nd</sup> Street, Cuyahoga Falls, OH-use lobby of police department. It has audio

and video cameras on at all times.

 Springfield Township Police Department — 2459 Canfield Road, Akron,

> OH-outside police department and is monitored by surveillance camera.

Here are some additional safety tips:

- Don't have the buyer or seller come to your home
- Take someone with you
- Meet at a public place or designated "safety zones"
- Meet during daylight hours

You'd think elderly people are easy targets. Well, people in their 20's are being targeted as well. Millennials rely on their phones and social media to communicate. Scammers use that to their advantage. According to the Federal Trade Commission, millennials are twice as likely as people who are 40 and older to get scammed while shopping online.

So what can you do to not get scammed? The first thing I tell people is to trust your gut. If it seems too good to be true, it probably is.



Recently, scammers have been targeting people who have new virtual assistants like Amazon's Alexa or Google Home. One of the latest trends is that scammers are trying to

convince people they must pay upwards of \$100 to activate those new devices. You don't have to pay to activate them. Criminals even developed look-alike websites to lure people who are searching for help with these devices.

Always check with a legitimate company. The contact information is usually with the device in its box.

A little thought goes a long way.

### TOP COP AKRON POLICE SGT. MICHAEL VAVRO Nominated by Assistant Prosecutor Felicia Easter

One recent case left a big impact on the community. 73-year-old Ernest Liska was struck and killed getting his morning paper. The suspect took off, eventually ditching his car at Akron's Water Reclamation Center.

Mr. Liska served in Vietnam, survived the 9/11 attack on the Pentagon, volunteered at his local church, helped students, and mentored veterans. Mr. Liska's death is a loss for our community.

If not for the hard work by Akron Police Sergeant Michael Vavro, the person responsible for Mr. Liska's death may not have been caught.

Sgt. Vavro assessed the scene, then spoke with a worker at the Akron Water Reclamation Center where the vehicle was discovered. That employee provided a vital clue about the suspect. The driver of the car which struck Mr. Liska dumped his vehicle and then took an UBER home!

While inspecting the suspect's vehicle, Sgt. Vavro discovered a gas station receipt. The receipt showed a purchase approximately 15 minutes before the crash. In following up on that lead, Sgt. Vavro retrieved video surveillance which provided him a picture of the suspect.

Now Sgt. Vavro knew the person who struck and killed Mr. Liska.

Sgt. Vavro's thorough, meticulous, and methodical investigation left no stone unturned. It was because of this investigation we were able to gather overwhelming evidence against Monte Porter, and hold him accountable for killing Ernest Liska.

Vavro made a potentially difficult case easy to prosecute. Based on his investigation Sgt. Vavro spared Mr. Liska's family the pain of a trial. Monte Porter knew he had no other choice than face the consequences.

Sgt. Vavro's work helped our office to get the maximum consecutive sentence for this defendant.

We have to help them navigate through that the best way possible. It can be very difficult because many times crime victims can be overwhelmed by what is happening. We do the best we can.

# HONORING VICTIMS

For over 20 years, the Summit County Victim Assistance Program has helped families who have lost loved ones to violence. To memorialize these individuals, the Victim Assistance Program conducts the annual Angel Tree Ceremony service at the Downtown Akron Public Library on the first Monday of December. This year's event is on December 2nd at 6:00 p.m. and is free and open to the public.

The community, as well as family members and friends of homicide victims are asked to place an Angel ornament on one of the Angel Trees on display.
