A MESSAGE FROM PROSECUTOR WALSH

SUMMER STORM SCAMS

It's June! We finally made it to warmer weather. With those backyard barbecues and lazy summer weekends also comes the danger of summer storms. Strong thunderstorms could knock down trees and cause significant damage to your home and

surrounding property. But beware before you contact a company to clean up the mess.

My office has prosecuted several cases where a

person has scammed a homeowner out of money by either not doing work or causing more damage.

One recent case involved a Sagamore Hills homeowner. 82-year-old George Homa needed some help in clearing debris from a November storm. He hired Alternative Property Maintenance to clean up the area around his home. During the process of removing the debris, workers were cutting down a tree when it fell on the home and trapped Mr. Homa. Mr. Homa suffered significant injuries and underwent three surgeries to repair a broken pelvis and shattered tibia. He was just recently discharged from a



rehabilitation facility where he spent
months recovering.

A follow-up investigation found the owner of Alternative Property Management, Cory Howard, broke several laws. He was charged and

eventually pled guilty. • He is now awaiting sentencing.

Though there are many reliable tree service companies, there is also the potential for scammers who want to

capitalize on homeowners who have been impacted by storms.

So what should you do if you need help removing debris?

- Don't pay cash in advance of the work being completed. Legitimate tree service companies will provide written estimates and be registered with the state.
- Call your insurance company immediately.
- Document the damage and take pictures or videos if possible.

- Obtain three to four estimates and compare based on the same specifications and make sure the tree service has all of the proper equipment to perform the job quoted.
- Get everything in writing. Make sure the agreement includes the business's information, project details, estimated start and completion date and the price. The contract should also be clear as to how clean-up will be handled. Only

pay the business in full once the job is completely done.

• Confirm the tree service is properly insured and check registration with the Ohio Attorney General's Office at

800.282.0515.

Remember, don't be pressured by someone knocking on your door demanding the work needs to be done immediately. Take your time and make the right decision!

TOP COP **AKRON POLICE DETECTIVE ROBERT VANEK NOMINATED BY ASSISTANT PROSECUTOR GREG PEACOCK**

Tracking down criminals is not easy. It can be even more

difficult if the criminal is a friend and respected member of the community. That's what members of the Akron Fire Department had to endure and why I nominate Akron Police Detective Robert Vanek as this month's TOP COP

The case involves defendant Joseph Ruhlin, who recently admitted to stealing close to \$400,000 from the Akron Fire Department's Union bank account. Ruhlin is scheduled to be sentenced on June 18, 2018.

Questions were raised by the union president in March of 2017 after he found out bills weren't being paid. That led to a nearly year long investigation conducted by Detective Vanek. Det. Vanek worked closely with then Union President Russ Brode, going over the union's finances in great detail.

It was determined Ruhlin stole \$385,000-money he used for a variety of personal expenses.

ALZHEIMER'S AWARENESS

June is Alzheimer's and Brain Awareness Month. It's also a

good time to remind you about our Take Me Home program.

Take Me Home is a secure database, accessible only by law enforcement, which is used to help reconnect

caregivers with children and adults who have a difficult time communicating and may wander from home. This includes people who may suffer from Alzheimer's disease.

The database contains a photo, contact information, and identifying characteristics that can be searched if a person is reported missing or is found wandering.

He uncovered various methods Ruhlin used to bilk the tens of thousands of dollars from his colleagues. Ruhlin withdrew cash, opened credit cards and even took out a high interest loan—all at the expense of the firefighter's union.

Deciphering financial crimes is often as laborintensive as solving a violent crime especially when the suspect moves money around and uses different schemes to cover-up his crimes. With

patience and hard work, Vanek was able to uncover the extent of the theft.

WHAT'S THE BEST PART OF BEING A PROSECUTOR?


I deal mostly with very violent cases including murders and rapes. I spend months working with victims and their

I left wanting to be a part of that and a desire to make a difference and help people deal with such a significant part of their lives.
