A MESSAGE FROM PROSECUTOR WALSH

PROTECTING OUR SENIORS

It can happen in an instant. Your identity and personal information made available for scammers and thieves. It just happened with Equifax, one of the country's top three credit reporting agencies. For about two months, hackers had access to people's names, social security numbers, and birth dates.

Now you're getting a call from someone claiming to be with Equifax. They want you to verify your account information. DON'T TELL THEM ANYTHING! It's a scam. Just like the other scams which target vulnerable people.

I've warned you about the Grandparents Scam, the Jury Duty Scam, and the IRS Scam. People call at all hours of the day, demanding that you pay immediately or you'll be arrested. Some of the calls may even sound convincing. But it's all fake—a scam to take your money.

Recently, a Tallmadge resident was called and told they owed the IRS \$4,000 and that if they didn't pay, the amount would jump to \$35,000. The caller used a phony Tallmadge police officer name. Even the number on Caller ID showed up as the Tallmadge Police Department nonemergency number. This is called "spoofing". That's when scammers use an application to make their number appear as if it was from a local business or police department. Thankfully, the person who received the call did not give any money.



These scams are one of the reasons why I declare each September as Senior Safety Awareness Month. I want to bring even more attention to protecting Summit County's seniors.

This month, my office is out in the community, giving safety speeches and holding self-defense classes to help people minimize their chances of becoming a victim. You can learn more about the locations and dates of the events by clicking on the link — <u>http://bit.ly/2vQriwS</u>.

There are things you can do right now to help minimize the chance of becoming a victim.

 Check your bank account as much as possible. That way you can immediately take care of a questionable transaction.

- No organization, company, or government agency will ask that you make a payment using gift cards. This should be an immediate red flag that you're being scammed.
- The Summit County Prosecutor's Office or Sheriff's Office will not arrest you for missing jury duty. You might get a strongly worded letter or even phone call, but you will not be arrested or fined.
- Try to have an answering machine for your home phone. If you see a number you don't recognize, let the answering machine pick it up. If it's important, the caller will leave a message. There are also several apps available to block telemarketers or potential scammers from calling you. Once you answer these calls, you are then added to what's called a "sucker list". You'll soon start getting a lot more calls!
- And when in doubt, hang up and ask someone you trust for help. And by all means, don't send money.

Hopefully you won't become a victim, and as always, stay safe.

TOP COP TWINSBURG POLICE DEPT. DET. BRIAN DONATO Nominated by Asst. Prosecutor Brian Stano

The wild west made a trip to America's heartland, and it landed one woman in big trouble. It's not often Northeast Ohio investigators handle a case involving horses. But that's exactly what landed in the hands of the very capable Twinsburg Police Department.



Investigating a regular crime, with just one victim in one location, has its own set of

challenges. Imagine looking into a case with 22 victims spread out all over the country. That is what faced Twinsburg Police Detective Brian Donato, and why I nominate him for TOP COP.

Lydia Culp was accused of selling horses to people across the country, but she never delivered. Culp also sold horse related materials which never existed. She bilked nearly two dozen people, including two 10-year-old boys from New Mexico, out of a total of \$130,000. Culp is currently serving a six year prison sentence. Not only did she steal their money, Lydia Culp stole their dream of owning their own horse. The work of Detective Donato was key in securing a conviction.

Detective Donato partnered with several local and out-of-state jurisdictions at the outset. He worked tirelessly to get copies of all the correspondence between the victims and Culp. He wrote a very detailed report which was easy to follow.

Detective Donato was also very attentive, assisting me with detailed information about the case. He personally contacted each victim to make sure all the information we had was accurate.

As this month's TOP COP, Detective Donato receives a gift card for his outstanding work.
