A Message From Prosecutor Walsh

Battling Domestic Violence

Summit County is dealing with the tragic aftermath of two recent domestic violence homicides. In Northfield Center, a January 11th house explosion left a family of four dead. Investigators say the father set fire to the home. And then on March 19th, Hudson police say a man killed his wife after luring their children out of their home.

Both cases have left the community horrified – and asking if something could have been done to prevent the tragedies. In the Hudson case, newspaper articles have said the victim had been estranged from her husband for months and that he violated a protection order. She even had a gun for protection. In the Northfield case, newspapers reported the husband had a history of suicide attempts and depression.

Ohio lawmakers are right now debating the Domestic Violence Offender Gun Ban bill which would prohibit persons subject to certain civil protection orders, as well as anyone convicted of a domestic violence crime, from buying or possessing a gun. Abusers would also have to surrender any weapons to law enforcement. The bill was introduced in the days following the tragedy in Hudson.

On a positive note, Summit County is the only county in the state with a courtroom dedicated to handling felony domestic violence cases. The Summit County Prosecutor's Office also has a team of highly trained prosecutors dedicated to assisting domestic violence victims. Offenders go through a thorough screening process to determine if they are eligible for an intensive 52-week program which aims at getting to the cause of the problem. The overall goal is to prevent any future acts of violence.



Our office handles approximately 300 intimate partner domestic violence cases each year. Unfortunately, these include homicides. Many times that is the first reported act of domestic violence. Domestic violence cases can be very difficult to prosecute because many times victims do not report. And the reasons why a victim may not report are many; fear of safety for their children, financial concerns,

shame, fear that they will not be believed, or they will be blamed.

Prevention begins with education. My office conducts trainings for law enforcement to update them on recent changes in the law. We also provide community education to highlight the importance of prosecuting domestic violence related crimes. There are some red flags if you suspect a friend or loved one is suffering from domestic violence:

- Spouse or partner is not allowed to have employment outside the home.
- They are not allowed access to bank accounts or money – put on an allowance.
- Isolated from friends and family members.
- Verbal abuse
- Threats of violence towards children and/or pets.

prosecutors cases by tracking down witnesses and victims and gathering anv information which may assist in the case.

Chief Led by Investigator Ben Bergeron, our




staff of 13 officers do an incredible job working with prosecutors and police in helping hold criminals accountable. The investigative unit is held to the same standards and annual qualifications as other police officers



under the Ohio Peace Officers Training Academy. The team provides a number of different services, which include serving warrants, conducting interviews, gathering evidence, and issuing subpoenas.

Ben, Investigator Jesse Recently, LeMasters and Property Officer Claude McCutcheon, went through weapons recertification at the Summit County Sheriff's Department Training Facility.

Summit County Sheriff's Deputy Provie Tomei led the trio through a series of scenarios to test their ability to use a weapon should they need to.



We hope they never have to use their weapons, but we are pleased to know they can protect themselves and the community when needed.

What to Know About Protection Orders

Who is Eligible?

• Victims of Domestic Violence, Assault, Stalking, Trespassing, & Menacing can get a protection order

How Can I Get a Protection Order?

- The Summit County Clerk of Court office has all of the paperwork to request a Protection Order.
- There is NO fee for obtaining a Civil Protection Order and you do not have to retain an attorney.
- A Magistrate will review your request. If the Magistrate grants your order, you will leave the courthouse that day with a protection order.
- For assistance contact the Summit County Victim Assistance Program at 330.376.0040 or Battered Women's Shelter of Summit and Medina Counties at 888.395.4357 and a victim advocate will assist you in obtaining the order.

Protection Orders

- 3 types—TPO (Temporary),
 CPO (Civil), & Anti-Stalking
 CPO
- Civil Protection Order (CPO) is a long-term protection order which may address issues of custody, property, and financial support
- Judge orders defendant to not have contact
- If Protection Order is violated—defendant could be arrested
