

# The Battle over Encryption

It's a battle of epic proportions. The Federal Government versus Apple. And your safety, not your privacy, could be at risk.

The debate boils down to this. 14 innocent lives were taken last December when two people dressed in black masks and tactical gear, armed with long rifles and




But information on any iPhone is blocked by Apple's encryption codes. Investigators do not know the phone's password and are afraid that after multiple tries, the phone would lock and the information would be lost forever.

The federal government has filed

several motions to compel Apple to create a program which would allow access to the shooter's iPhone, something which right now does not exist. Apple has refused, saying doing

so would set a dangerous precedent and jeopardize the privacy of millions of people around the world.

But the privacy of millions of people would NOT be



Apple has asked a Federal Court to vacate a California magistrate's order which would force the tech giant to help FBI agents access the phone. Apple's CEO Tim Cook even wrote a letter to customers detailing why the company feels so strongly about not allowing the FBI to have access.

But Apple is wrong. Although our country was built on freedom, it is the government's responsibility to keep us safe. The government is only asking Apple for permission to use a computer to "guess" the passcode on the shooter's phone.

For example, police get a search warrant for a safe deposit box at a bank because they believe it contains evidence of a crime. But they cannot open the box because the bank has thrown away its own key. The bank could, and most likely would, be able to make another key for that one specific box. investigators would not have all the keys to all the safe deposit boxes. Just the one key to open the one box.

Drug dealers use cell phones to communicate with buyers. Child pornographers download and share pictures and movies using cell phones. Sex traffickers communicate with their customers via text messages. And terrorists use cell phones to plan their next attack. Simply stated, passcode-protected devices encourage criminals to act without fear of being caught. The ultimate losers in this equation are crime victims. Encryption does not protect privacy. It protects criminals.

## **March Top Cop**

### Akron Police Detective Mark Hockman Nominated by Assistant Prosecutor Kevin Mayer

On November 15, 2015, one of the largest pit-bull dog fighting rings in Northeast Ohio was raided on Cordova Avenue in Akron. 48 people

were arrested. Akron Police Detective Mark Hockman led the investigation.

His passion about getting to the bottom of what happened was key to the prosecution. Acting on information received prior to the dogfight, Detective

Hockman secured a search warrant for Alvin Banks' home. A large tactical team comprised of 52 law enforcement personnel including members of the FBI, Summit County SWAT, Akron Police SWAT, Akron Gang Unit, Narcotics, patrol, and the Humane Society of Greater Akron was assembled. The tactical raid was the largest single SWAT raid performed in

Akron. It included an armored personnel carrier which was used to breach the home's outer perimeter.

Shortly before 11pm, the raid on Mr. Banks residence commenced. Upwards of 60 suspects who had gathered to take part in the spectacle took off running in all

directions. Money and drugs were thrown all over the place as the participants ran off. In all, 48 suspects were arrested and eight pitbull dogs were rescued, two of which were severely injured due to the dog fighting operation. Over \$52,000 was seized, along with weapons and a sophisticated marijuana grow operation.

Of the 48 suspects, nine were from out of state. Several traveled thousands of miles, from as far away as California, North Carolina, Chicago, Pittsburgh, and Indiana. 10 individuals were charged in federal court with dogfighting and related crimes. All 10 pled guilty. The remaining suspects made their way through the Summit County court system. During trial, Detective Hockman was determined to be an expert on dogfighting. His expert testimony helped secure guilty verdicts on all of the trials.

- Protect your information online—use a secure internet connection.

Margaret Scott joined the Summit County Prosecutor's Office in 2003 after nearly a decade of legal experience, in private practice handling civil cases, and as a public defender dealing with criminal cases. She began her tenure with Prosecutor Walsh as a courtroom prosecutor assigned to the Child Abuse Unit. She was later promoted to the position of a supervisor in the Violent Crimes Unit. After having tried over 100 jury trials, Margaret was promoted again in 2009 and currently serves as Deputy Chief Assistant Prosecutor overseeing the Criminal and Juvenile Divisions. She also serves as the Program Coordinator for the felony Domestic Violence Court and was instrumental in helping that program become the first felony Domestic Violence Court in Ohio to be certified by the Supreme Court. She is a member of the Akron Bar Association and serves on the Bar Association's Commission on Judicial Candidates which determines the qualifications of candidates for Judge in Summit County.
