A Message From Prosecutor Walsh

SENIOR SAFETY MONTH

Since taking office in 2001, it has been my mission to make Summit County safer. And for much of my adult life as a lawyer and prosecutor, my main goal is to fight for people's rights, especially victims. That's why September holds a special place for me.

Soon after being elected Summit County Prosecutor, I declared September Senior Safety Awareness Month. Every September it is my goal to bring awareness to specific crimes where seniors are targeted. I feel this is an important issue to devote an entire month to and to give Summit County residents, especially seniors, the tools they need to protect themselves.

Throughout the month, my office will be involved in community events, educating as many senior citizens as possible about scams, criminal activity, and how to protect your home. Unfortunately, many criminals see seniors as vulnerable and weak. But knowledge is strength and learning how to avoid certain situations will give you the power so you do not become a victim.

You can take action right now to protect yourself. Scam artists are always devising plans to either steal your money or identity. The Grandparent and Jury Duty scams are just two ways you can be a victim. Your first thought when answering the phone is to trust the person on the line. But that trust can cause you to lose thousands of dollars.

Here are some tips to remember so you do not become a victim:

- Never send money or give out personal information such as credit card numbers, bank account numbers, dates of birth, or Social Security numbers to unfamiliar companies or unknown persons.
- If you have doubts about a telemarketer's legitimacy, be sure to ask for their company's name and address, along with a phone number where they can be reached at a later time.
- For elderly widows, if a caller asks for the man of the house, be sure not to say that there isn't one or indicate that you live alone.
- Talk to family and friends or call your lawyer, accountant or banker and get their advice before you make any large purchase or investment over the phone with a stranger.
- Check out unfamiliar companies

with your local consumer protection agency, Better Business Bureau, the National Fraud Information Center, or other watchdog groups.

Be sure to sign up for the Federal Trade Commission's Do-Not-Call-Registry. Telemarketers who continue to call you after you have registered are subject to penalties. You can sign up at www.donotcall.gov or at (888) 382-1222.

Don't forget the power to simply hang up the phone when a stranger calls trying to sell you something you don't want!

But also beware of people going door -to-door trying to sell you something. A typical scammer might say they have some leftover materials from a job just down the street and notice you need some work done to your house. Unless you know them or a trusted neighbor refers them, just tell them you're not interested. If they persist, call the police.

Doing these simple things will help protect you and your family.

We assisted over 200 parents, resolved over 50 outstanding warrants and helped reinstate drivers' licenses for over 100 non-custodial parents who owed back child support. 75 employees and volunteers assisted during the 6th annual event. And for the first time, FirstMerit Bank provided its mobile unit to help attendees get



information about their credit score as well as offered other financial services.

Several local agencies took part in the successful event including

Summit County Sheriff's Department, Department of

Veterans Affairs, Summit County Fatherhood Initiative, Summit County Common Pleas Court and Summit County Chief Magistrate Ron Cable.





And the Summit County Prosecutor's Office was among one-thousand people who attended a rally to bring awareness to the heroin crisis sweeping our community.

The heroin crisis affects every community and every

neighborhood and does not discriminate based on race, gender, economics or age.

August 31st was International Overdose Awareness Day. Take time to help others caught in the

grips of addiction. And please remember those who have succumbed to the grips of this addiction.

We will continue to hold people accountable as well as work with community leaders on possible solutions.

I spent some time with the new volunteers at the Rape Crisis Center.




They do a great job helping survivors of sexual assault. I'm so happy we are able to work together to help victims.

THE NEEDS OF CRIME VICTIMS

The Summit County Prosecutor's Office is very proactive in responding to the needs of crime victims. Now, we are taking that pledge one step further, and helping train others in Summit County on how to help crime victims.

The Summit County Prosecutor's Office Victim Services Division assisted close to 2,000 victims and their families last year. Being a victim of a crime can be very stressful and emotional. And not all crime victims respond the same way. So how do first responders, investigators, counselors, and even family members, handle the various emotions and reactions of crime victims? That's why we are taking action.

Crystal Baker, the Director of our Victim Services Division, has put together a FREE one-day conference: Responding to the Needs of Victims. On September 29th, law enforcement officers, victim advocates, and key members of the community will come together to learn, teach, explore, and discuss some very difficult topics.

Among those scheduled to give a presentation is Doctor Jim Hopper, a nationally known expert on the impact of sexual assault on people. Dr. Hopper will take a closer


WITNESS WAITING ROOM

TOP COP

SUMMIT COUNTY SHERIFF'S DETECTIVES JASON KLINE AND LARRY BROWN NOMINATED BY NIK BUCKMEIER

Tracking down a person who is sending and receiving child porn can be very difficult. Many times, these criminals hide behind fake names while trolling chat rooms.

But we were able to secure a conviction in one of these cases thanks to the hard work and dedication of three law enforcement officers, including two Summit County deputies. That is why I am nominating

Summit County Sheriff's Detectives Jason Kline and Larry Brown.

Detectives Kline and Brown followed up on the investigation started by Detective Randall Snyder of the Pinal County, Arizona Sheriff's Department.

The initial investigation led to Curtis Burden, who was posting explicit pictures and videos of children. Kline and



Brown obtained search warrants for two apartments and seized several electronic devices. Because of that evidence, officers were able to arrest and charge Curtis Burden who eventually confessed.

Detectives Kline, Brown, and Snyder performed an exhaustive investigation culminating in not only a confession from Curtis Burden, but a conviction. As a result

of their hard work, Curtis Burden is now serving a six year prison term.

As the September TOP COPS, Detectives Kline and Brown are the recipients of a gift card from Bricco Downtown and Luigi's Restaurant. Thank you Bricco and Luigi's for your support of our office and local law enforcement.
