A Message From Prosecutor Walsh

Working For Our Community

The Summit County Prosecutor's Office fights for victims and works hard to improve the lives of the residents of Summit County. One of the goals during my time as Summit County Prosecutor is to prevent crime and give people the tools they need to empower them to not become victims. From sending out alerts about scams to organizing self-defense classes, I urge all people to become more aware. I also feel



strongly that we should help raise people up so they become productive members of society.

That's why I want to tell you about a newly formed organization in Summit County called the Community Works Connection. Run by Bob Titus, the CWC is a job recruitment program seeking to help those in poverty become economically self -sufficient through a holistic approach to job training, job placement and job retention. Participants are provided

with resource support including transportation, childcare, finance and budgeting, mentoring and more. Many of the organization's participants have never held a job, or even understood what it means to schedule time to work. I know that sounds foreign to many of you, but it's true. And the CWC is trying to break that cycle.

My office, and more specifically the Summit County Child Support Enforcement Agency, began working with the CWC earlier this year. CSEA Outreach Coordinator Lisa Dolan runs our Family Support Matters program within CSEA. Family Support Matters addresses non-payment of child support by trying to eliminate payment problems. Lisa has referred several people from Family Support Matters to the Community Works Connection. Many of them are now working and paying child support.

But there's more. After attending a recent CWC graduation, Lisa noticed something was missing. A true graduation feel. The participants did not have typical caps and gowns. Lisa strongly believed this was a key element to give these graduates the full experience. For many graduates, this is the first time they accomplished something positive. Lisa reached out

to Seth Yon at Greener Grads in Michigan. Greener Grads recovers, reuses and repurposes graduation



gowns in an effort to be more environmentally friendly. Seth was so moved by Lisa's story that he provided us with a discounted price for graduation caps and gowns. The Summit County Prosecutor's Office purchased 15 sets and presented them to Bob Titus at CWC just in time for the March 27, 2015 graduation.

This is just one example of how members of my office truly care about the community. Congratulations to the graduates of the Community Works Connection!

Keeping The Community Safe

The heat is on! So as you try to find a spot to cool off during the hot summer months, don't forget about your furry friend!

We say it often, but please keep an eye out for my friends. I enjoy going to the park and hanging out on a nice big lawn. But make sure pets, especially

dogs, have enough room to move around. Plus, leave out plenty of cold water. And make sure animals have



some shelter in case of bad weather. And under no circumstances should you leave an animal in a car with the windows up. Lowering the window by a small amount does not offer any relief on a hot day.

There is a new proposal to toughen Ohio's animal cruelty laws. My good friend, and animal rights activist Dick Goddard (you might know him for his weather forecasts!) is behind the idea.

It's called Goddard's Law, and would make the worst acts against companion animals a felony. Someone convicted of knowingly injuring or killing a companion pet, or depriving it of food, water, or shelter, would face between six months and a year in prison, plus a \$2,500 fine.

Ohio is one of only five states in the country where cruelty to pets is a misdemeanor.

So when the weather gets uncomfortable for you, just imagine what it's like for me and my friends! This fur is great in the wintertime, but can be uncomfortable once the temperatures rise. So please remember to be kind to your pet.

Community Works Connection


Archmoody proposed a new way of thinking to help people living in poverty to become selfsufficient. That is how the Community Works Connection was born last November.

Modeled after a similar program in Cincinnati, the Community

Works Connection, or CWC, is an intensive, month-long program geared to give those who are willing and capable a chance to break out of poverty.

Participants attend classes Monday through Friday, eight hours a day where they learn about financial literacy,
