## A Message From Prosecutor Walsh

# **Our Facility Dog Makes History**

History was made in October in Ohio. And it involved the Summit County Prosecutor's Office and a key member of our staff who provides comfort and support to victims. I have always made helping crime victims my main objective. Being a victim of crime can be a traumatic experience. And that victimization can continue, survivors as tell prosecutors investigators and what happened. That's why I brought Avery II on board in August of 2013. The Summit Prosecutor's Office County remains the only one of 88 prosecutor's offices in Ohio to use a facility dog to help victims and their families.

The history making case involved Michael Jacobs. Jacobs is currently serving a four-year sentence after being convicted in 2014 of unlawful sexual conduct with a minor and corrupting another with drugs. Avery sat at the feet of Jacobs' victim while she testified. Avery's presence helped the victim tell jurors what happened. Jacobs appealed saying

Avery should not have been allowed in the courtroom.

Ohio's 9<sup>th</sup> District Court of Appeals disagreed. The judges ruled that courts can make a variety of allowances for child special victims of sexual abuse. And those allowances may include using a companion dog during the child

victim's testimony. This is the first time in Ohio an appeals court has ruled on the use of а facility dog in a trial.



The crimes we prosecute are some of the worst imaginable. While we work hard to protect victims, the criminal justice system can inadvertently cause what is known as secondary victimization. Children and people with disabilities can be especially fearful and stressed when describing a traumatic situation in a courtroom. Avery

plays a vital role in how my office focuses on the needs of crime victims. He often sits with victims and their families as they tell their investigators story to and prosecutors.

Avery is a highly trained facility dog helping crime victims feel more at ease. My hope is that Avery makes the whole judicial process easier to handle. We also have great community support, including Canine Companions for Independence who trained Avery, Stow-Kent Animal Hospital which provides free health care for Averv, and free food and grooming from Pet Supplies Plus in Green.

Our goal is to get the truth out. Many times, a young victim won't speak about the horrible things that happened to them. But Avery gives them control – they pet him, play with him, and he calms them down. The interaction is incredible. And we are happy that interaction will continue.

advocating for your safety. Elliot testified before the Ohio House Judiciary Committee in support of Senate Bill 97.



Senate Bill 97 would create a Career Violent Criminal designation. The designation would add additional prison time for someone who has been convicted of at least two violent felonies within eight years of each other.

One of the main goals of the Summit County Prosecutor's Office is to keep the community safe, and help people not be victims of crime. We

continued on that journey with stops at two local communities.

On Tuesday October 13th, Deputy Chief Prosecutors Margaret Scott, Joe Fantozzi, and John Galonski spent time at Roses Run Country Club in Stow, presenting our self-defense class and safety speech to about 50 seniors.





Then on Thursday October 15th, Deputy Chief Prosecutor Joe Fantozzi, and Assistant Prosecutors Joe Dangelo and

Heaven Guest, spoke to about 40 members of

Cardinal Retirement Village in Cuyahoga Falls. They offered vital safety tips, including information on recent scams and crime.




Our 2016 Senior Safety Awareness Calendars are here! Lots of great information to keep you safe.

# Happy Trails Animal Sanctuary

Recently, Summit County Prosecutor Sherri Bevan Walsh and several Assistant Prosecutors toured the Happy

Trails Animal Sanctuary in Ravenna. Happy Trails has spent nearly 20 years rescuing neglected, abused, and abandoned farm animals in Ohio and nearby states.



Among the barns, stables, and pens on dozens of acres are survivors, some from Summit County. The sanctuary works in cooperation with county humane societies, animal protective leagues, and local law enforcement.

Workers and volunteers rescue, rehabilitate and provide an adoption program for abused, abandoned, and neglected farm animals. Horses, ponies, pot-bellied pigs, farm pigs, chickens, ducks – you name it – if the animal suffered some form of abuse, the folks at Happy Trails work to give that animal the best care they can.

Happy Trails also has an Amish horse retirement program.

The sanctuary accepts Amishowned buggy and plow horses which can no longer serve their

Amish families. The horses are then checked



out and given updated vaccinations and an overall medical exam. Then they're made available for adoption.

# Angel Tree Ceremony

Since 1994, the Victim Assistance Program has grieved with hundreds of Summit County families who have lost


loved ones as a result of violence. As a way to memorialize these individuals, Victim Assistance Program staff invites you to join them on Monday December 7, 2015 to participate in the annual Angel Tree ceremony and homicide memorial service.

This event is free and open to the public. Each year over 200 individuals attend and participate.

Family members and friends of homicide

victims are asked to submit a photo of their loved one to display on the VAP Wall of Remembrance. These photographs remain on the wall throughout the month of December to honor those not forgotten.

When friends and family of homicide victims arrive at the event, they will be directed to a memorial



angels to their seats and hold them close during the ceremony. Those in attendance will be invited by VAP to address the audience and share messages to their loved one before adorning the tree with their angels.

Following the placement, VAP will present a slideshow with the 900+ names and pictures of those whose lives were taken as a result of violence during the last 20 years. Homicide victim angels who do not have any

family or friends present will be hung on the tree by volunteers, police officers, and advocates.

This year's ceremony is scheduled to take place on December 7, 2015 at 6pm at the Akron-Summit County Public Library. For more information please visit victimassistanceprogram.org.
