Facebook Scams


Facebook provides exceptional opportunities for people to connect and share information; it also serves as a great platform for scammers. They hide behind special offers, exclusive content or new apps in order to obtain your account information or to spread viruses and other malware.

Here are some recent examples of viral scams. Maybe you have noticed them in your news feeds...

- 1.**Profile Viewers and Profile Blockers** These scams promise to show you who has been looking at your profile or who has blocked you from theirs. NONE of these apps work.
- 2. Free iPads & iPhones Don't be fooled by messages stating you can test and keep an iPad, iPhone etc. They are all marketing gimmicks. If it sounds too good to be true, it usually is.
- 3. Free Facebook Credits Credits are used to purchase items in Farmville, Cityville, etc. Credits cost real money and you aren't going to receive a large sum for free.
- 4. Free Items, Gift Cards & Tickets You will not get free airline tickets, Subway or Starbucks gift cards or a Facebook hoodie just by completing a survey.
- 5.**Breaking News Stories** Anytime a major news story breaks, keep your guard up. Scammers love to trick unsuspecting users with promises of "exclusive coverage."

- 6. Phishing Attempts to Steal Your Login Info-If a scammer can get your login credentials, they can wreak all sorts of havoc before you are able to reclaim your account. Messages pretending to be from Facebook Security is a popular trick.
- 7.New or Extra Facebook Features Dislike buttons, apps to change your Facebook color or see who unfriended you are some examples of these scams. While there are legitimate browser extensions that offer these features, scammers often insert adware or malware into the plugins. Only install apps and extensions from trusted, well-known developers.
- 8.**Shocking & Sexy Headlines** Anything that starts out with "OMG" or "Shocking" is best left alone on Facebook. Victims are lured in with outlandish, steamy or perverted messages and usually end in a survey scam and a video that doesn't play.
- 9."Help I'm Stranded and Need Money" If you get a message from a friend saying that they are stranded in London or some other exotic locale, don't rush down to Western Union to send them cash. They have likely had their Facebook account hi-jacked by scammers.

Take control of your privacy settings and manage the privacy of your posts. Always verify the information you receive and don't spread messages just because they were shared by your friends. Check for scams on websites like FaceCrooks.com and Snopes.com.

November Top Cops

Sergeant Steve Dunton and Special Agent Brenda McNeeley Nominated by: Assistant Prosecutors Dustin Roth & Pete Daly



On March 20, 2014, Roxanne Buck was arrested for the murder of her roommate, Michelle Johnson. Johnson was stabbed in the throat several times, wrapped in a blanket, and placed in the backyard shed.

Sergeant Steve Dunton of the Stow Police Department was in charge of the case and coordinated the investigation with the Bureau of Criminal Investigation. He conducted several interviews with the defendant in which he was able to lock Buck into a specific timeline and statements. The information that he gathered became essential for cross examination when Buck testified. Sergeant Dunton worked with prosecutors for several months to prepare for trial by following up on various parts of the investigation and ensuring all of the necessary evidence was sent to BCI for testing. After more than 35 years of service, Sergeant Dunton retired from the Stow Police Department while the case was awaiting trial, but he continued working on it to see it through to a conviction.

Special Agent Brenda McNeely led the crime scene investigation for BCI. She spent twelve and a half hours processing the crime scene, photographing and documenting all evidence. Special Agent McNeeley conducted a full



analysis of blood evidence at the scene, which showed where the murder had taken place and the efforts Buck had made to hide her crime by cleaning up. She thoroughly prepared for her testimony at trial, which enabled her to explain to the jury how her analysis coincided with the evidence at the scene.

Thanks to the outstanding efforts of both Sergeant Dunton and Special Agent McNeely, Roxanne Buck was convicted of Murder and Tampering with Evidence on October 21, 2014. She was sentenced to life in prison and will not be eligible for parole for 18 years.

The organization offers numerous youth programs and hosts several recovery meetings for people seeking sobriety. The Front Porch Café is only one of their many programs

designed to connect and serve people in the Akron area. The Front Porch Café provides employment and training to ex-offenders in order to help them provide for themselves and get back on their feet, while acquiring the basic skills necessary to join the workforce. The café prides itself in being a place of middle-ground. They work to serve and employ people of all races, genders, social classes, and belief systems.

It is a way for the public to invest in the Akron community and in its residents as well. Consumers of the Front Porch Café are investing time and money to the employees of the Front Porch Café, to South Street Ministries, and to the mission they are continuing to serve.

The café serves breakfast, lunch, and dinner and is open Monday through Friday from 7:00 am-3:00 pm. They are located at 798 Grant Street in South Akron.

The case that has always stuck with me was an Endangering Children charge that involved a 3 year old boy who was punished for wetting himself. The mother's boyfriend forced the boy's naked body into a tub of scalding hot water causing third degree burns on his hands, buttocks and feet. The defense hired experts, the defendant cried, but the jury found him guilty and he was sentenced to eight years in prison. It was a great feeling to help a family and see a child abuser punished.
