Dr. Jackson Katz



Where does sexual violence stem from and how can we create a culture of non-violence? Dr. Jackson Katz, popular author and educator, and one of America's leading anti-sexist male activists, believes strong male leaders can guide the way to ending domestic violence.

Dr. Katz recently delivered his "The Macho Paradox" presentation to a crowd at The University of Akron, on October 7, 2014. Katz's visit was sponsored by the Rape Crisis Center in partnership with UA student organizations.

Dr. Katz touched on a number of issues related to domestic violence and sexual abuse. He feels strongly that we need to stop blaming the victim and start blaming the abuser. He considers violence against women a men's issue and one that they can help solve through strong leadership by educating our young and taking a proactive role in society as ACTIVE bystanders.

My office aggressively prosecutes these cases but I agree with Dr. Katz that more male leaders speaking out and educating our children on what is acceptable behavior towards one another is needed to end this vicious cycle.

I welcome the opportunity to work with local leaders and agencies to improve the quality of life for those who struggle with abuse.

Avoid the Green Dot Card Scam

Reports of telephone scams in our area seem to be increasing. One of the common scams involves Green Dot cards (cash-loaded cards).

These Green Dot cards make the transfer of money quick, easy, and virtually untraceable. Customers can purchase and load the cards right at the store register with amounts that typically go up to \$1,000.

Green Dot scams include hoaxes such as family members claiming to be in trouble or jail, police officers calling and demanding payment for release of a loved one who has been jailed, debt collectors threatening court proceedings if immediate payment is not made via the prepaid cards, and callers claiming the victim has won a cash prize which they can collect after paying the taxes or fees.

The scam artist then asks the victim to scratch off the back of the card and provide them with the card number. When the victim complies, he or she gives the scam artist instant access to the cash loaded onto the card.

Our office urges everyone to be wary of any telephone calls by anyone requesting payment through the use of Green Dot or any other prepaid debit cards. Remember, utility companies and government agencies will not contact anyone demanding immediate payment by Green Dot cards.

October Top Cop

Detective Stephen Coburn

On February 1, 2014, Michael Person raped and beat his girlfriend. He then directed Deandra Thomas, an associate, to rape her as well which he

did, twice. Person then kept her at his house for the next two days, through intimidation.

On the afternoon of February 3, 2014, the victim escaped Person's house while he was away. She went to the hospital and reported these events and the hospital contacted the local police.

Det. Stephen Coburn of the Barberton Police Department responded to the hospital. He took a statement from the victim which allowed him to identify Michael Person and get a physical description of the other assailant.

Det. Coburn subpoenaed hospital records, followed up on a series of text messages between the defendant and victim and subpoenaed the phone records. Additionally, he gathered physical evidence and sent it to the Bureau of Criminal Investigation for analysis. Det. Coburn laid all the groundwork for an excellent case before speaking with Person, ensuring that he would have a good case whether Person cooperated or not.

Because of Det. Coburn's hard work, Deandra Thomas was convicted of two counts of Rape and one count of Felonious Assault at trial on August 26, 2014. On Septem-

During Domestic Violence Awareness Month, it is important to note that a victim's safety is not secured just because a police report is filed or because someone has called 911. Sometimes, it takes a little extra effort on all of our parts to ensure the safety of victims who come forward, much like Det. Coburn did in this case.

I also spent time at both Suicide Prevention Services and CHOICES for Victims of Domestic Violence. I have a wonderful family with my husband Jeff: three children, a son and two daughters. My oldest daughter has autism.

Tell us about your program: The Take Me Home Program is sponsored by Summit County Prosecutor Sherri Bevan Walsh and Sheriff Steve Barry. The program consists of a database of individuals who may have trouble communicating their name and where they live-such as people with autism, Down Syndrome, non-verbal individuals with cognitive disabilities or senior citizens with dementia or Alzheimer's. The Take Me Home database contains a photo, identifying characteristics and contact information. It is a valuable tool for law enforcement agencies as well as families and caregivers. In the event a person is lost or separated from their loved ones, a search of the database on the individual's name, phone number or physical characteristics will allow law enforcement personnel to match their Take Me Home record to their contact information. Only law enforcement personnel can access the Take Me Home database. We currently have more than 1,500 individuals registered in Summit County.
