Do You Have a Plan?

As the Summit County Prosecutor, I am very much aware of the crimes being committed in our communities. We all read articles in the newspaper and hear stories on the television news programs about crime. However, the crimes you read and hear about in the paper or on television represent only a very small number of the total number of crimes being committed. Last year, my office prosecuted to conclusion, 3,909 adult defendants who committed felony crimes in Summit County. Felony crimes are the most serious crimes such as murder, rape, robbery, kidnapping, drug offenses, child abuse and burglary.

Although most victims will blame themselves, they are NOT to blame. The criminal is to blame. However, because we live in a society where crime continues to occur, we must do everything possible to minimize our chances of becoming the next crime victim. Here are some tips I have shared over the years to help senior citizens stay safe:

- Rehearse a plan in your mind where you tell yourself what you
 will do if you are attacked. My office sponsors self-defense classes throughout the year where we demonstrate easy techniques to
 get out of a potentially dangerous situation. See back page for

- If you are in a public place where other people are likely to hear you, scream as loud as you can and do anything you can to draw attention to the situation. Criminals do not want to get caught and most will panic if you are making a lot of noise.
- If you have a gut feeling that someone or something is not quite right, do not ignore that gut feeling because your instinct is probably right. Most victims of crime have told me that they had a bad feeling about the criminal and wish they had not ignored their instinct.
- Do not assume you are safe just because it is daylight and you are in a public place. There are just as many crimes committed during the day as there are crimes committed at night.
- Always lock your car door.

Crimes Against Seniors



On the night of September 7, 2018, Jack Godfrey broke into the home of his neighbor, a 65-year-old-single woman. He kicked in the front door, bound the woman's hands with tape and demanded money. When the victim attempted to run out the door, she was

pulled back in and hit in the face with a metal pipe. Godfrey eventually ran off and the victim hid in the woods until police arrived. On January 16, 2019, Godfrey pled guilty to Aggravated Burglary and Felonious Assault. He will be sentenced on February 21.



Raymond Gates was sentenced on September 5, 2018 to **three years** in prison for sexually assaulting a 62-year-old mentally disabled woman. The victim was able to go to a neighbor's home for help. Gates was also labeled a Tier 3 sex offender which requires him to register his address

with the local sheriff every 90 days for the rest of his life



Crystal Hennacy received **nine years** in prison and Kevin Story received **four years** for the theft of \$600,000 from Story's elderly father. They used the money to buy a

house, several vehicles, jewelry and even a second honeymoon. Meanwhile, Story's father died penniless in a nursing home. The elder Story died before seeing these two defendants sentenced in court.
