A Message From Prosecutor Walsh ARRIVE ALIVE FOR THE HOLIDAYS

The holiday season is here! A wonderful time to spend with friends and family. My hope is that you have a safe and healthy holiday, no matter how you celebrate.

Throughout the years I have noticed that holidays and alcohol many times go hand in hand. Maybe it's a beer when you are out with friends. Or it's a mixed drink during a holiday party. Or a glass of wine at dinner. Either way, once you drink you should give your car keys to someone else. Getting behind the wheel even after one drink is a recipe for disaster.

December is National Drunk & Drugged Driving Impairment Awareness Month. The time between Thanksgiving and New Year's Day is described by the National Association of Drug Court Professionals as "one of the deadliest and most dangerous times on America's roadways due to an increase in impaired driving".

My successful Arrive Alive program is back for Christmas and New Year's Eve. During our recent Thanksgiving holiday, over 130 people used our code for a FREE or reduced fare ride home from LYFT. And with your help, my hope is that more people will use the service during Christmas and New Year's Eve.

My office is providing 300 one-time use codes during the Christmas and New Year's Eve holidays. The codes give the rider up to \$20 in credit for a LYFT ride.

For Christmas, the codes can be used starting at noon on Christmas Eve through 6pm, Sunday December 26th.

You can enter the code—SUMMITXMAS to receive the discount.

For New Year's Eve, the codes can be used starting at noon on Friday, December 31st through 6pm on Saturday January 1.

For New Year's Eve the code is—SUMMITNYE.

I urge you not to drive while under the influence of alcohol or drugs. Not only is it illegal, but it puts you and everyone around you at risk. Accidents caused by driving under the influence are totally preventable. Besides using my Arrive Alive program, here are a few tips to remember as you attend holiday parties and other get-togethers this year.

 Always plan ahead. Designate a sober driver, and arrange for an alternative route home just in case.

- If you are a parent, grandparent, aunt, uncle, or even friend, talk to your loved ones and remind them how important it is to be responsible and stay safe.
- If you are the one hosting the party, always offer a nonalcoholic option for drinks for your guests so they can still have

ONLINE SHOPPING SAFETY

CRIME & PUNISHMENT

With the holiday season here, many of you are still shopping for that perfect gift. Going online might be the easiest and fastest way to cross shopping off your list.

But be safe when you click for those best deals! Here are some tips to remember when shopping online.

- Beware of e-skimming while shopping online: Cybercriminals can capture credit card and personally identifiable information by skimming your data online. Look for the "s" in "https" to ensure that a website is secure.
- Make sure to research online reviews: Watch out for generic names and profiles that do not include a photo. If you see consistent reviews on several online stores, it may add validity to the feedback.
- Check return policies: In Ohio, sellers can set their own return policies, including policies of "no returns," but any retailer whose policy limits your ability to obtain a refund must clearly notify you of that policy before you complete the purchase.
- Keep cybersecurity in mind: When shopping for deals online, don't use free public Wi-Fi when entering sensitive information such as a credit card number. Keep apps, software and operating systems up-to-date and use secure websites whenever you need to enter personal information.
- Monitor your accounts: Regularly check your credit card and bank accounts for unauthorized charges or unexpected activity. If you find problems, immediately notify your credit card provider or bank. The sooner you identify a problem, the sooner you can work to correct it.

Also, check those delivery dates. Shipping can be expensive and maybe even delayed.

REMEMBERING JUSTIN

This time of year can bring a lot of emotions; joyous times being with friends and loved ones and pain from missing those gone too soon.

For the Summit County Prosecutor's Office, this time of year brings both as we remember Akron Police Officer Justin Winebrenner.

On November 16, 2014, Justin was with friends at Papa Don's Pub when another customer, Kenan Ivery, returned with a gun after being asked to leave.

After seeing the gun, Justin, along

with two others, confronted Ivery and tried to get him outside and away from the crowd of people inside the bar. Ivery opened fire and shot Justin twice. Justin collapsed in the parking lot and died a short time later. But his actions undoubtedly saved the lives of others inside the bar. Ivery is now serving a life sentence with no eligibility for parole.

For many, that one moment and one sacrifice is how Justin will be remembered — as a hero.

perspective that puts our problems into a larger, more balanced, framework. Behind all the difficulties that our world has faced, if we look a little deeper, we can find a light that shines within us. Below are some wonderful successes that have happened in our world in 2021:

In March of 2021, Ngozi Okonjo-Iweala made history by becoming the first African and the first woman to serve as director-general of the World Trade Organization.

A Dutch Museum (the Rijksmuseum), for the first time in its two-century history, permanently features women artists.

A breakthrough for those with spinal cord injuries occurred when scientists at Brown University fully connected a human brain to a computer via a transmitter device. Trial participants with paralysis were able to move robotic limbs by simply imagining their movements.

Maria Clemente Garcia and Salma Luévano made history in Mexico as the first openly transgender lawmakers elected to the country's lower house of Congress.

Dapper Dan became the first Black designer to receive the CFDA's lifetime achievement award. He is widely known for introducing luxury fashion to the hip-hop world in the 1980s through his shop in Harlem. He is the first Black designer, as well as the first designer who has not had a solo runway show, to win this award.

WHY I'M A PROSECUTOR ASST. PROSECUTOR LAURYN KITCHEN

Each month one of our Assistant Prosecutors discuss why being a prosecutor is so important to them. "Why I'm A Prosecutor" gives them a chance to tell their own story.

Assistant Prosecutor Lauryn Kitchen, who works in our Criminal Division, provides insight into why being a prosecutor is so important to her.

WHY DID YOU BECOME A PROSECUTOR?

When I was in law school I had an opportunity to work for a law firm that did municipal prosecutions. I hadn't thought about criminal law until that point. It was a pretty complex menacing by stalking case. As I started looking through the case, I realized my brain just clicked with criminal law. I also love working with victims and guiding them through the criminal process. I learned that I enjoyed teaching them how to present their case at trial. That's when I realized I needed to become a prosecutor. Ever since that day I started looking for opportunities and that's why I'm here today.



WHAT'S THE BEST PART OF **BEING A PROSECUTOR?**

The best part of being a prosecutor right now is we achieve justice. But justice comes in a variety of forms. It's not just winning at trial and going to sentencing. It's also being a facilitator of accountability. Sometimes the justice system allows someone to confront an

addiction, with accountability and responsibility and I get to be a part of that.

WHAT'S THE MOST DIFFICULT PART OF **BEING A PROSECUTOR?**

The most difficult part of being a prosecutor is sometimes not being able to prove your case. Someone is always impacted by that decision, and it's usually the victim. We have a great justice system but there are times we cannot prove our case because we just don't have the evidence.
