The new year also provides an opportunity to start fresh and make resolutions to improve our lives. Unfortunately, criminals use that as an opportunity to take advantage of people. I want to make sure you have the information you need to protect yourself from some of the more popular scams.

How many of you resolve to lose weight and improve your health in the new year? Gyms are typically filled with new members who are full of energy in trying to reach their goal. However, one thing you might want to avoid is ordering pills and weightloss supplements which are advertised on social media.

The Better Business Bureau warns against jumping on any deal you see advertised. Many offer great deals on samples, but then charge you lots more once those 30 days are up.

The wintertime also brings cold and snow! As the snow piles up, don't let your frustrations lead to a scammer.

If you're looking for a snow removal service, do your homework. These tips will hopefully spare you some aggravation and money!

CHECK WITH YOUR LOCAL CITY— Many local cities request snowplow businesses register with the city.

**ASK YOUR NEIGHBORS** — See if they have hired someone and find out how much experience they have.

**ASK FOR INSURANCE** — Make sure the business has insurance in case a plow hits something.

**REVIEW THE CONTRACT**— Check to see when payments are due and the snowplow company's responsibilities.

Scammers increase their calls this time of year, especially ones who claim to be from the power company. They threaten that your power will be shut off unless you pay up.

No one wants to lose power, especially when the weather gets cold. If you get one of these calls, hang up and find your bill. Call the number from your bill to make sure you are connecting with the actual power company. And never give any personal information to someone who calls you.

The new year might also bring a great deal. Who doesn't love a good deal? But be careful of coupons you see on social media and in your email. They will look very real but can be fake!



To get the discount, you might be asked for your name, date of birth,

even your social security number and credit card information.

Remember to never provide your date of birth to someone online and check a website's security information before you give your credit card information.

Congratulations to Summit County Prosecutor Sherri Bevan Walsh, who was named the Ohio Prosecuting Attorneys Association's 2021 "Outstanding Prosecuting Attorney". The "Outstanding Prosecuting Attorney" recognizes Prosecutor Walsh for her continued fight for the rights of victims as well as her determination to hold criminals accountable.

Prosecutor Walsh is the 37<sup>th</sup> recipient of the OPAA's "Outstanding Prosecuting Attorney" award and only the third woman to ever receive the award

The Ohio Prosecuting Attorneys Association also honored Summit County Assistant Prosecutor Dangelo with the "Meritorious Prosecuting Attorney" award for his work in securing a conviction of Stanley Ford in the murders of nine people in two separate fires.



Mr. Dangelo is the fourth

Summit County Assistant Prosecutor to receive the OPAA's "Meritorious Assistant Prosecuting Attorney" award. Prior recipients include Brian LoPrinzi (2001), who nominated Mr. Dangelo for the honor.



# New Franklin Police Officer Ethan Brown & Fmr. New Franklin Officer Savannah Selden Nominated by Asst. Pros. Zachary Neumann

Many times this newsletter has mentioned that domestic violence cases are some of the more difficult situations law enforcement officers encounter.

This was the case in November of 2020 when New Franklin Officers Ethan Brown and Savannah Selden responded to a domestic disturbance call. Officer Selden arrived first and attempted to separate the parties involved. Officer Brown arrived just as Officer Selden attempted to detain the suspect.

The suspect resisted and threw several punches at the officers and attempted to place Officer Selden in a headlock. Officer Brown was able to deploy his taser and both were able to subdue the defendant.



Throughout the entire process, the Defendant insulted, attacked, threw punches, and kicked at the two officers. Both officers acted with extreme professionalism and did not lose their cool. This professionalism carried over to the court proceedings. Both Officers Brown and Selden attended meetings and testified at trial. At every step of the way both officers' professionalism allowed the Defendant to be found guilty and brought to justice.

The defendant, Jerold Van Sickle, was found guilty of Assault on a Peace Officer.

# WHY I'M A PROSECUTOR JACQI CORGAN

"Why I'm A Prosecutor" gives our prosecutors the chance to tell their own story and why being a prosecutor is so important to them.

As we begin a new year, their dedication to the community, and to finding truth, hasn't changed.

Assistant Prosecutor Jacqi Corgan, who works in our Appellate Division, talks about why being a prosecutor is so important to her.

#### WHY DID YOU BECOME A PROSECUTOR?

I became a prosecutor because of a woman I met while I was a newspaper reporter in Warren, Ohio. I covered many trials and ended up sitting next to a woman named Miriam Fife, who was one of the few victim advocates in Trumbull County. After speaking with her and learning about the murder of her son, I realized that if I ever became an attorney that I would want to work as a prosecutor to help people like Miriam in order to be an advocate for victims of crime.



### WHAT'S THE BEST PART OF BEING A PROSECUTOR?

One of the best parts of being a prosecutor is that I actually fulfill what I set out to do, which is to help protect victims, to protect my community, and to serve justice.

### WHAT'S THE MOST DIFFICULT PART OF BEING A PROSECUTOR?

One of the most difficult parts of being a prosecutor is what we see. You see the ugliest things which happen in society and you have to confront them every day. Even though I am in appeals and am more separated from the day-to-day courtroom situations which many of my colleagues see, I still have to experience the cases by reading through transcripts of the trials. It can be very difficult at times.
