## A Message From Prosecutor Walsh SEASON OF SCAMS!

The holidays are here and it's time to celebrate with family and friends.

Many of us are on the lookout for the perfect gift. For some, that means a gift card to their favorite store. But don't let the holiday season turn into a season of scams!

If you're looking to buy gift cards this holiday season, pay close attention because scammers are increasingly using gift cards as a way to steal your money.

One way is the gift cards are opened, redeemed, then re-sealed and sold again. Scammers often copy the card number and PIN, then carefully place the card back in the rack, often behind other cards.



The Better Business Bureau has some suggestions to make sure you don't get a bogus card.

 Look for any tampering or tears of the gift card package before purchasing.

- Any scratches on the card that might indicate something on the card might not be right.
- Signs that a sticker was placed over the original bar code.
- Be very cautious of re-sell sites advertising gift cards at steep discounts. It's best to buy gift cards directly from the store.
- Don't delay using a card, because the longer a card sits around, the more likely a cyber-criminal can steal the balance.
- Register your card if given the option.
- Find out if a gift card has any strings attached. Some have a certain timeline to be used.

Lots of stores have big discounts for those last minute shoppers. If you're heading out to get that perfect gift—and perfect bargain—remember these important tips so a criminal doesn't target you.

- Try to shop during daylight hours. If you must shop at night, take a friend or family member.
- Be alert of your surroundings.
   Always look around to see if someone is following you.

- Keep a record of all of your credit card numbers in a safe place at home in case you lose your credit card.

- Trust your instincts. If you are out shopping and something doesn't feel right, contact the store manager to have someone escort you to your vehicle.

I did just that recently. Although it's a new experience, I'm glad I still get to help.




I want to make sure my four-legged and furry friends are safe during the holidays.


- Make sure your Christmas tree is anchored. That way one of my furry friends won't knock it over!






December of this year kicks off a year-long campaign to promote and recognize the 75<sup>th</sup> anniversary of the Universal Declaration of Human Rights (UDHR). On December 10, 1948, the United Nations adopted this document that had been drafted by representatives of many different cultures and nations.

After the second world war, many nations felt it was necessary to have set universal human rights that provided freedom and equality to ALL humans. The document contains 30 rights that have become a benchmark for countries when it comes to human rights. The first Article of the UDHR, and often the most quoted is, "All human beings are born free and equal in dignity and rights."

The theme for the 75<sup>th</sup> anniversary is "Dignity, Freedom, and Justice for All." With rising tensions over the last few years from the Covid-19 pandemic, as well as economic instability, racial injustice, and conflict throughout the world, the rights guaranteed in

## **AKRON FIRE DEPT. ARSON INVESTIGATOR GABRIEL COTRUFO**

### NOMINATED BY ASST. PROSECUTOR DEVORAH PASTERNAK

Our TOP COP nominations are usually for local law enforcement officers whose work had a tremendous impact on one of our cases.

This time, an Akron Fire Department Arson Investigator is our TOP COP. The dedication and creativity of Arson Investigator Gabriel Cotrufo led to us securing a conviction.

Summer Huston was living in a house with five other people. Huston thought someone stole from her and messed with her stuff, so she set the place ablaze and took off.

People heard Huston make incriminating statements before she left the house. However, what really solidified the case Huston is currently serving a 3.75—to—5.75 year prison was all the jail call research Investigator Cotrufo did, sentence. uncovering incriminating statements, including multiple calls.



The most important call Investigator Cotrufo located was not so obvious.

Roughly 40 minutes after the first 911 call went out, Huston's boyfriend called her on a recorded line from the county jail. During the call Huston repeats three times that she just burned down the

house. This call was critical to the case and was uncovered because Cotrufo did social media research and found the connection between Huston and an individual in jail and started listening to his jail calls to see if he talked to her.

Because of all of this extra work we were able to get convictions on several aggravated arson charges.
