



AVOIDING TEXTING SCAMS

Every September, the Summit County Prosecutor's Office declares the month Senior Safety Awareness month. It's a time where we refocus our efforts to help protect seniors.

One of the biggest safety concerns we see are scams targeting the elderly. Our office works hard to keep on top of the latest scams targeting the community. Now a

new scam has popped up claiming people owe outstanding tolls.

Have you received a text with a link for you to pay the Ohio Turnpike toll fees? Scammers are now sending texts to your cell phone demanding payment. Don't click on the link!

This latest scam has criminals sending text messages claiming to be from the Ohio Turnpike Commission and demanding you pay an outstanding toll or E-Z Pass fee. A link included in the text takes you to a website where you can enter information and pay the outstanding bill. But the website is fake. Once you enter your information, the scammers take your money and have your credit card information to steal more money.

The Ohio Turnpike Commission does not request payment by text nor do they collect unpaid tolls via text. The only website links associated with the Ohio Turnpike's E-Z Pass accounts are ezpassoh.com and ohioturnpike.org.

The scam is called "smishing" — a combination of the abbreviation SMS (text messages) and "phishing". Phishing is when scammers



impersonate a legitimate government agency or business and send out a link hoping someone clicks on it.

Similar scams include ones from either the Post Office or Amazon claiming you have a package but the delivery person either can't find your house or can't deliver the package without more information. Sometimes a text demands you renew a subscription. Or

perhaps you've won a fantastic prize. Or the text claims that there is suspicious activity on your account. The texts include a link which takes you to a fake website.

One simple way to avoid becoming a victim of these scams is to take a moment and question whether the information in the text is legit. Are you expecting a package? Did you recently drive on the Ohio Turnpike? Did you sign up for a contest with a prize?

If you do get one of these texts, you can report it to the Federal Trade Commission by forwarding the text to 7226 (SCAM) or report it to your cell phone carrier. Then delete the text and block the number from your phone. Hopefully that will prevent others from becoming a victim and stop these types of text message to your cell phone.



Also, never click on the links in the texts or reply to these text messages. If you have a question or concern about the text, reach out directly to the company named in the text using verified contact information. That way you know who you're communicating with and protect yourself from becoming a victim.

CHILD SUPPORT AGENCY EQUITY & SOCIAL JUSTICE

Over the last month the Summit County Prosecutor's Office Child Support Enforcement Agency has been involved with some exciting events. On August 14th, CSEA and Habitat for Humanity held the 2nd annual Build a Home project. This year CSEA sent ten volunteers to help frame and add siding to a new home. Habitat for Humanity provides homes to low to moderate income families, with those families taking part in the construction. September is a month filled with remembrances and celebrations, but there was a recent day the Ambassadors

would like to bring to your attention.

Women's Equality celebrated every August 26th, is the day Congress designated as Women's Equality Day in 1971. The day commemorates the passage of women's suffrage in the U.S. and reminds us of the hurdles



overcome by the heroic women who faced violence and discrimination to propel the women's movement forward.

In the early 19th century, American women, who generally couldn't inherit property and made half of the man's wages in any available jobs, began organizing to demand political rights and representation.

In the U.S., the 19th Amendment to the Constitution was first introduced in 1878, but it failed to gain traction. It wasn't until women's involvement in World War I made their contributions painfully obvious that women's suffrage finally gained enough support.

Because a Constitutional amendment requires approval from two-thirds of the states, 36 of them had to ratify the 19th Amendment before its passage. The deciding vote in the Tennessee legislature came from Harry T. Burn, a young state representative whose mother's plea to support the amendment became a deciding factor in his vote (which he switched at the last minute).

Women aren't done fighting for equal rights. Today, the wage gap between men and women still impacts women's economic power, and gender-based discrimination still plagues workplaces and businesses transactions.

New this year is a series of short videos providing tips to seniors on how to avoid being a victim of a scam. In the video Prosecutor Kolkovich highlights five separate scams which target seniors and gives important information to help seniors and their family members be safe. The billboards have a variety of messages, including "Be Mindful of Scams", "Don't Give Information, Get Information", "Verify, Verify", and "Don't Answer Unknown Numbers".
