



ONE-DAY EXPUNGEMENT EVENT

Being charged with a felony offense is serious. Being convicted of a felony charge can change your life forever. So what happens when a person convicted of a low-level, non-violent felony does everything asked of them by the court and prosecutors? Should they be given a second chance?

We think so. We've teamed up with Summit County Clerk of Courts Tavia Galonski for a oneday expungement event. This event is for Summit County Clerk of Courts people eligible under Ohio law to have their Tavia Galonski criminal case sealed or expunged.

"These are people we have convicted who have done everything we and the court have asked them to do. They've earned the right for a second chance," said Prosecutor Kolkovich.

"Being able to wipe the slate clean of a mistake made in the past is sometimes the only way that members of our community can move forward with their lives," said Clerk Galonski. "As the Summit County Clerk of Courts, I'm thankful to be able to assist people on that journey forward through events like this."

This one-day FREE expungement event is the first step for people with felony convictions in Summit County to have their record sealed if it meets requirements under Ohio law.

The following services will be provided:

- Summit Legal Defenders will assist in sealing and expunging records as permitted by Ohio law.
- Summit County Executive's Department of Job and Family Services will provide information about job training and other local programs.



- Summit County Child Support Enforcement Agency will help with restoring driver's licenses.
- Summit County Fiscal Office representatives will have Veteran ID Cards available with a valid DD214 (honorable discharge) plus two additional forms of ID.

Ohio law requires a \$50 filing fee to process all expungements, but that fee may be waived based on income.

The event is scheduled for Tuesday, October 29, from 10 a.m. to 2 p.m. at the Summit County Courthouse Ceremonial Courtroom. The Summit County Courthouse is located at 205 South High Street in downtown Akron. Parking will be validated for those who park across the street at the County garage.








IN THE COMMUNITY


CHILD SUPPORT AGENCY EQUITY & SOCIAL JUSTICE

The Prosecutor's Office Child Support Enforcement Agency attended the 2024 Ohio Fatherhood Summit in Columbus.

At the Summit, the mission for CSEA representatives was simple — to become Myth Busters and assist Ryann Levering-White, the Director of Public Policy at the Ohio Child Support Professionals Association, with her presentation on Child Support: Common Myths and Misperceptions.

The presentation focused on clearing up the most common myths or misconceptions concerning child support including these two:

permitted to establish parenting time. Some counties can establish child support and parenting time together so long as the parties are in agreement.

Another misconception is genetic testing is too expensive. Either parent can complete a child support application and the Child Support Enforcement Agency will conduct genetic testing at no cost. CSEA will complete a free genetic test as long as there has not been a court order naming a father.

Summit County Child Support Enforcement Agency representatives can discuss these issues, or anything else you need to know about your case.

Hispanic Heritage Month is celebrated September 15

October 15 to recognize and celebrate the rich heritage of Americans with roots in 20 countries, such Mexico, Central and South America, the Caribbean, and Spain. Although the official term "Hispanic" is what most of us are familiar with, it does not fully embody the wide range of diversity in



cultures, races, or even languages which comprise this vibrant community.

It's important to note that although the terms "Hispanic" and "Latino/a" are often used interchangeably, they do not mean the same thing. "Hispanic" refers to people whose ancestors are from any Spanish-speaking country while "Latino/a" refers to people whose ancestors are from Latin American countries and the Caribbean. This includes Brazil where Portuguese is the native language.

You might wonder why Hispanic Heritage Month is split between two months. The celebration coincides with the Independence Day celebrations of multiple Hispanic/Latin American countries: September 15 - Costa Rica, El Salvador, Guatemala, Honduras, and Nicaragua; September 16 -Mexico; September 18 - Chile; and September 21 - Belize. Also within the month-long observation is Indigenous Peoples Day, which is celebrated in Mexico on October 12.

In the current climate of negative and divisive rhetoric that surrounds us, the Ambassadors for Equity and Social Justice encourage you to seek out knowledge. Read about cultures that are different than your own. Experience festivals and traditions you have never encountered. Learn about art, music, food, and the many contributions from this community that has played important roles in our nation's history since the time of the American Revolution. We handed out safety information, plus our anti-fraud pens, and fun puzzle books!




The Summit County Prosecutor's Office works hard to help those in need in our community.

TOP COPS

STOW DET. MIKE MURPHY & OFC. TAYLOR PAXTON & AKRON POLICE DET. JOSEPH SMITH NOMINATED BY ASST. PROS. RIMMA AVANESYAN & JOVANA ILIC

This month's TOP COP nomination involves three officers from two different law enforcement agencies in Summit County. It shows how the collaboration between agencies is vital to holding offenders accountable and keeping Summit County safe.



The case involved a road rage incident in Stow where police responded to a man being struck by a vehicle. The victim suffered several injuries and eventually needed surgery which resulted in a months-long recovery.

Stow Detective Mike Murphy and Officer Taylor Paxton determined the driver responsible took off and was possibly in Akron. Det. Murphy and Ofc. Paxton immediately secured the scene and attended to the victim. Once they found out details of what happened, they



reviewed city cameras and identified a license plate of the suspect's vehicle. That license plate was registered to a person living in Akron. They called Akron Police Detective Joseph Smith and requested assistance. Det. Smith found the vehicle and identified the defendant.

The case went to trial where jurors found the defendant guilty of vehicular assault and was sentenced to prison. Thanks to the diligence and hard work of all three officers, the defendant was held accountable for his actions.
