PROPERTY FRAUD PROTECTION

Summit County Fiscal Officer Kristen Scalise has a warning for local residents-scammers have set their sites on property titles and deeds. According to Scalise, there has been a slight increase in title and deed theft and fraud.

Here's how it works. The scheme involves criminals filing a forged document to show a fake transfer of property ownership. Criminals then sell the home, take out a mortgage, or even try to rent it out. In some cases

"While it doesn't happen often in Summit County, we have seen an uptick in title theft and deed fraud over the past couple of years," said Fiscal Officer Scalise. "So as a proactive measure, I am proud to offer this free monitoring system to all Summit County property owners".

According to the FBI's 2023 Internet Crime Report, nearly 10,000 property owners and renters in the United States were victims of real estate fraud with losses totaling over 145-million dollars.

across the country, people have been charged with forging documents on dozens of homes at a time.

from their home. Others have spent thousands of dollars

for down payments or rental costs as they try to buy or rent a home which is not lawfully available.

Scalise's office is now taking а pro-active approach in protecting Summit County citizens from this type of criminal activity. lt's а free Property Record Alert



system. The alert system will notify property owners through email when any documents are filed using their personal information. The automated email is sent to the homeowner and has details of what was filed.

The homeowner can then use that information to see if any fraud has been committed or if the filings are valid.

To sign up, property owners can visit the Fiscal Office's Self Service Site at https://summitcountyohweb.tylerhost.net/web/user/disclaimer, and click on The impact can be devastating, with some people evicted Property Record Alert. Email alerts can be configured based on first and last names or business names.

> Summit County residents who receive an alert that appears suspicious or fraudulent can contact the Summit County Fiscal Office Recorder Division by calling 330-643-2712 or emailing summittreas@summitoh.net.

> You can also check with your insurance company to see if they offer a specific "Homeowner's Policy of Title" insurance to further protect you against this type of fraud. While

this policy won't prevent title or deed fraud, it could eliminate the expense and hassle for the homeowner as the insurance company tries to resolve the phony title claim in court.

Hundreds of people attended Faith & Blue, which showcased nearly 80 houses of worship, law enforcement agencies, and


community organizations!

CHILD SUPPORT AGENCY EQUITY & SOCIAL JUSTICE


The Summit County Prosecutor's Office Child Support Agency continues to look for ways to improve its presence within the community. The Agency recently launched the Safe Access Program to assist survivors of domestic and intimate partner violence by providing safe access to child support services. One in four women and one in seven men have been victims of severe physical violence by a domestic partner.

The Safe Access Program is a victim-focused intervention program to help clients in the following areas:

- Provide information on victims' rights. •
- Help create a safety plan. •
- Provide referrals for other services and or resources. •
- Assist clients with filing protection orders •
- Assist clients with the next steps.
- Emotional support for survivors and their families.

Safe The Access program works with Child Support staff to increase their knowledge about domestic violence.

The Safe Access unit was created to help put together a system of accountability within the agency to fully



understand the sensitive nature of domestic violence.

Referrals from child support staff are based on the following:

- Previous history of domestic violence with ongoing • fear.
- Any current criminal charges involving clients and or children.
- Threats of safety.
- Any current or expired orders of protection. •

November is Native American Heritage Month, a time dedicated to recognizing and honoring the history, culture,

contributions and of Indigenous peoples across the United States. From their agricultural innovations and contributions to science, medicine, and government, Native American influence is woven into the fabric of our everyday lives.



This year, Native American

Heritage Month takes on added significance as President Joe Biden recently issued an historic apology for the federal government's role in the Indian boarding school system. During his speech, President Biden formally apologized for the devastating impact of boarding schools that forcibly assimilated Native American children for over 150 years.

These schools, which aimed to strip away cultural identity, often subjected children to physical, emotional, and sexual abuse, and resulted in the deaths of more than 950 students. This apology marks a significant step in recognizing the harm inflicted by these policies and the enduring trauma they caused to Indigenous communities.

Hayden Gilbert, a member of the Ambassadors for Equity and Social Justice, was honored to help tell one of these stories by writing original music for a documentary called "Diligence."

Created by Brooklyn Demme, this short film is about a Sandhill Band of Lenape & Cherokee Indian family historians, Norris Spotted War Turtle Branham and Carrie Ruffin Jones. It chronicles how they work diligently to honor, preserve, and restore their ancestral inheritance in "Scheyichbi" or "New Jersey." EXPUNGEMENT FILING DAY

ADAM IN FEDERAL COURT

The Summit County Prosecutor's Office, along with Summit | The Summit County Prosecutor's Office works hard to County Clerk of Courts Tavia Galonski and the Summit Legal Defenders, held a first-ever one-stop expungement filing day to assist people looking to have their felony convictions sealed or expunged.

The event, held at the Summit County Courthouse's facility Ceremonial Courtroom, brought in close to 170 people. Several arrived an hour before the event started. A number sentencing at the Carl of people who attended had cases dating back over 30 years. Having a felony conviction can prevent a person from getting a job or even a driver's license.

"These are people we have convicted who have done everything we and the court have asked them to do. They've earned the right for a second chance," said Prosecutor Kolkovich.

"Our Prosecutor, Elliot Kolkovich, had a great idea and I am glad we ran with it," said Clerk of Courts Tavia Galonski.

"We offered education to our returning-home citizens, and they responded with hope in their eyes."

"The first woman I helped had a low level theft conviction from 1997 and has had no other offenses since then. We did this clinic for people like her," said Prosecutor Kolkovich. "It's great to put together a program that gives a second

chance to people who deserve it, like her."

In addition to having their felony convictions reviewed, the Summit County Fiscal Office assisted any veterans who needed an ID. Representatives from Summit County Adult Probation, the Summit County Executive's Office, and the Summit County Child Support Enforcement Agency were also at the event to help those who attended.

HEALTH CARE FRAUD SPECIAL AGENTS BRIANA ELLIS & DEBORAH GEARHISER NOMINATED BY ASST. PROS. EMILY WILLIAMS

The Summit County Prosecutor's Office handles a variety of criminal cases, including people who target the elderly.

Recently we prosecuted a defendant who was charged with

patient abuse. The victim was an elderly patient at a local nursing home. The Summit County Prosecutor's Office nominates Health Care Fraud Special Agents Deborah Gearhiser and Briana Ellis from the Ohio Attorney General's Office.

Both Agent Gearhiser and Agent Ellis went above and beyond in their work on this case. Although based in Columbus, both would travel to Akron to knock on doors to try and track down witnesses. In addition, this was the first time Agent Ellis testified at trial. She did a terrific job explaining to the jury what happened.

They were also extremely helpful

in contacting people to ensure

they were going to show up for

the trial. Some of the witnesses

had moved out of the area and

were difficult to track down.

Although jurors reached a not guilty verdict, the work of both Agents Gearhiser and Ellis were phenomenal.
