A NOTE FROM THE PROSECUTOR



According to AARP, in 2024 fraud and scams cost Americans \$47 billion. There are millions of survivors of financial crime; but scam survivors often don't talk about their experience due to the stress, anxiety, trauma, and even embarrassment over what happened to them.

Even being the Prosecutor doesn't keep me safe from being targeted by scammers.

A few weekends ago, I travelled to Washington, D.C. with my family. Almost immediately upon our return to Ohio, I started getting texts about missed toll bills I needed to pay. I also started getting texts about parking tickets in another out-of-state town I had recently visited to see family.

Because the texts made sense in the context of my recent travels, I was worried they might have some merit. But rather than clicking any links sent to me or contacting the number I was contacted by, I found trusted contact information for the organizations that these texts would have come from—if they were legitimate. After reaching out to the alleged sources directly, I found out that both series of texts were merely scams.

The timing and specificity was panic-inducing—which is exactly what scammers want. They want you to feel pressure to take immediate action before investigating further, clicking the link they sent or prompting you to provide your personal information so they can gain access to your bank account.

Scammers do a lot of research and use advanced technology to create convincing and targeted scams. Your reaction to any text or call from an unfamiliar source should always be to GET more information—never to give it. Always verify the source before trusting it.

Keep trusted, known numbers of your banks, government agencies, and other businesses you frequent so you know who to reach out to if you receive a concerning call or text. It's the best defense against scams.





UNPAID TOLL BILLS

Many Ohioans have been receiving texts asserting they have "unpaid toll bills." Do NOT click on any links in these texts. Ohio Turnpike officials have issued the following guidance:

- Phone numbers appear to be randomly chosen and do not have to be associated with toll road use.
- Ohio Turnpike E-ZPass does not request payments by text. Collections of unpaid tolls and/or toll violations do not occur by text.
- All links associated with Ohio Turnpike E-ZPass will include <u>www.ezpassoh.com</u> and <u>www.ohioturnpike.org.</u>
- If you're concerned, call the Ohio Turnpike's E-ZPass customer service center directly at (440) 971-2222.

OHIO BMV OUTSTANDING TRAFFIC TICKETS

Ohio residents have reported receiving text messages from scammers claiming to be from the Ohio Bureau of Motor Vehicles and informing the recipients that they have an outstanding traffic ticket. The text then instructs the recipient to pay immediately to avoid a license suspension. This particular scam is a phishing attempt that is being reported by drivers nationwide and is designed to trick residents into giving up personal or financial information.

Ohio BMV Registrar Charlie Norman has stated that "Ohio BMV will never send you a text message demanding payment or requesting your personal information."

JUNETEENTH





TOP COP: Lieutenant Matthew Whitmire Akron Police Department



Lieutenant Matthew Whitmire was nominated by Assistant Prosecutors Rimma Avanesyan, Jovana Ilic, and Charles Roman. Lieutenant Whitmire took over a case where a victim had to spend multiple days in the hospital after being assaulted by three individuals. Lieutenant Whitmire's diligent investigative work and follow-up in this case, as well as his professional testimony, were crucial to the indictments, and ultimately the convictions, of all three co-defendants.



On any case he works, Lieutenant Whitmire always completes any follow-up that is needed. He cares about each and every one of his cases, and continues to investigate even after a suspect has been charged or indicted. His persistent work on cases even after an arrest has been made has been critical in promoting and serving justice in Summit County.

TOP COP: Detective Joseph SmithAkron Police Department



Detective Joseph Smith was nominated by Assistant Prosecutors Rimma Avanesyan and Kevin Day for his exceptional work on a complicated felonious assault case. In the case, the defendant was unlawfully residing in a condemned house, and shot and injured a contractor who had been hired by the city to secure the building.



As the lead detective on the case, Detective Smith displayed professionalism, persistence, and attention to detail. He conducted witness interviews, pursued leads, submitted physical evidence to the Bureau of Criminal Investigation for analysis, and carefully reviewed all aspects of the case. Throughout the process, Detective Smith remained accessible and engaged, attended meetings with prosecutors, and providing continued support throughout trial preparation and the trial itself. His commitment to thoroughness and justice reflects the highest standard of law enforcement.


As we enjoy the warmth of the season, may it also inspire us to be generous, hopeful, and active in our communities—not just for today, but for the generations still to come.
